## **Portrait of the Association**

SAREPTA Suisse is an association which is non-lucrative and is exempt from taxes in Switzerland. She was created on the 18<sup>th</sup> of December 2015. Her mission is to contribute for the improvement of rural health and development in Côte d'Ivoire. She does this through:

- The construction of health centers which meet modern standards
- The furnishing of top-quality material for these centers
- The staffing of these centers with qualified professionals who are interested in the problems of rural health
- The promotion of good health by the health teaching done by the center's staff that will inform and stimulate better health and prevent health problems for the local populations.

#### The committee is composed of:

- The president: Mme Marie-Aimée Päivi Soro, medical doctor. She is actually serving in the internal medicine department at the hospital of Yverdon.
- The general secretary: M. Navigué Pierre Soro, BS in management of human resources, Master's in Biblical Exegesis and Linguistics, English and economics teacher in various private schools.
- The treasurer: Mme Sarah Seri, special education employee at the Foundation EBEN-EZER
- M. Eloge Seri, Interactive Media Designer at the Center for Digital Education, EPFL.

### **Activities**

The objectives for 2016 were:

- 1. The recruitment of new members
- 2. The establishment of administrative recognition for the association in both Switzerland and in Côte d'Ivoire
- 3. The creation of a building plan for the medical center
- 4. The establishment of the budgets for constructing and equipping of the center
- 5. The search for funding agencies

The year 2016 ends with 3 members added to the four on the committee.

A building plan has been created with the appreciable help of a qualified architect.

The secretary general made a trip to Côte d'Ivoire from June 16 to July 28 and obtained the following results:

- The creation of a local representation. This committee is composed of a president, Karime Anderson, a general secretary, Mme Robin Hampton, a treasurer, M. Moussa Silué. The local representation rapidly increased its numbers to a total of 12 at the end of the year.
- The establishment of a constitution and internal working document for the local representation before the proper authorities
- The beginning steps with the Ministry of the State to obtain the necessary permission for the association through its local representation to carry out its activities within the country.




- The initial meeting and information necessary for the village chief of Tangafla and his advisors and the population in order to obtain their approval and support of the project and to obtain from them a parcel of land on which to build the center.
- The request of local administrative authorities to use the land donated...insure that a clear title will be possible for the parcel and that there are no other claims to the property.
- The securing of 3 different construction estimates by qualified builders.

Following this trip, the construction budget was established. The permission sought from the Ministry of State was granted on January 2, 2017. The local representation obtained the official letter from the administrative authorities giving clear right to the land as well as a letter signed by the village chief and his advisors ceding the land officially.

At the end of the year we were still waiting for the administrative authorities in Switzerland to declare the association an "organization of public utility and therefore exempt of taxes." It was finally obtained February 28, 2017.
